The History of FBGA

FBGA was formed in 2003 after victim/survivors of Quarriers Homes were attacked in the Scottish media by ex-employees of Quarriers Homes.

These Ex-employees and their supporters mounted a vicious campaign from a number of "Quarriers" properties claiming they had been falsely accused!

FBGA has to-date had no funding from the Scottish Executive. We are and remain a fully
